**Spencer Boyer** is the National Intelligence Officer for Europe in the National Intelligence Council and an Adjunct Assistant Professor at the BMW Center for German and European Studies at Georgetown University. He has also served as a Deputy Assistant Secretary of State for European and Eurasian Affairs.

**Jon Clifton** is Managing Director of Gallup's Global Analytics and a member of the company's Executive Committee. He is also a nonresident Senior Fellow at Baylor University's Institute for Studies of Religion.

**Jeremy Ferwerda** is a post-doctoral fellow at the Watson Institute for International and Public Affairs at Brown University. His current research addresses issues of decentralization and immigration, with a regional focus on Europe.

**Caglar Özden** is a Lead Economist in the World Bank's Development Research Group's Trade and Integration team. His research explores the nexus of globalization of product and labor markets, government policies and economic development.

**Demetrios Papademetriou** is Distinguished Senior Fellow and President Emeritus of the Migration Policy Institute (MPI), and President of MPI Europe. He is the convener of the Transatlantic Council on Migration.
